# SOUTHWEST TENNESSEE COMMUNITY COLLEGE

## SUBJECT: Testing and Evaluation for Student Placement and Satisfaction

### (merged the Testing and Evaluation and Assessment and Placement of Students policies)

EFFECTIVE DATE:July 1, 2000; Revised April 13, 2023

#### Purpose

The purpose of this policy is to establish assessment and evaluation guidelines for placement at Southwest Tennessee Community College ("Southwest" or "the College").

## Definitions

Weighted GPA- grade point average (GPA) that includes extra points for honors and advanced placement courses, which allows a student to exceed a 4.0 GPA.

Unweighted GPA- one that reflects grades on a 4.0 scale without regard for the difficulty of the coursework and, thus, gives no extra points for honors or advanced placement courses.

#### Policy

I. In an effort to ensure that students are adequately prepared for college level courses and that each has a reasonable opportunity to succeed in their studies, the College, in accordance with Tennessee Board of Regents (TBR) <u>Policy 2.03.00.03</u> (Learning Support-formerly A-100), requires that all students granted degree admission and all others for whom it is specifically required in the <u>General Admission policy</u> are subject to the applicable assessment requirements stated herein.

Unless otherwise exempt by high school weighted GPA, ACT scores, transfer credit, or other means, all degree-seeking applicants are encouraged to take a placement test that is designed to measure skills in reading, writing, and math. Approved cut scores (as prescribed by <u>TBR</u> <u>Policy 2.03.00.03</u>) for placement into college-level courses are listed below.

Southwest provides academic support, known as Learning Support, using the framework provided in "Fundamental Features of Co-Requisite Remediation" as outlined in <u>TBR Policy 2.03.00.03</u> (Learning Support – formerly A-100).

- A. The College will use official GPA, ACT, or SAT scores no older than 5 (five) years (prior to the first day of the first term of enrollment) to determine proficiency and readiness for college-level work for all applicants.
- B. For applicants who have not taken the ACT or the SAT test or whose scores are not current, or whose high school GPA is more than 5 (five) years old, Southwest offers the Residual ACT® test and the Accuplacer placement exam. While the Residual ACT® test can be used to enroll at Southwest, the score will not transfer to other institutions and will not be used to qualify for the Tennessee Education Lottery Scholarship program.
- C. The following applicants are required to take all areas of the Accuplacer placement exam prior to enrollment in order to determine placement in college-level courses:
  - 1. Those who on the first day of classes of the term of initial enrollment have no transfer credits from other institutions.
  - 2. Those who have earned a GED or HiSET and have no transfer credit.
- D. Transfer students who have not completed at least one (1) college-level English and one (1) college-level Mathematics course with a "C" or better from a regionally accredited institution will be required to undergo an Accuplacer assessment in the appropriate areas (i.e. writing, reading, and/or mathematics).
- E. Students whose high school GPA, ACT, SAT, or COMPASS test scores do not indicate proficiency and readiness for college-level work must complete the prescribed remedial and developmental courses in reading, writing, and mathematics prior to enrolling in college courses for which such skills are prerequisite.
- F. All students are evaluated for placement testing according to TBR <u>Policy</u>, <u>2.03.00.02</u>, Learning Support.
- II. To ensure the quality and effectiveness of its academic programs, the College requires that all students participate, as a condition of graduation, in College-wide activities to evaluate and assess curriculum and instruction. Participation in such activities may be requested of all students or of a statistically represented group. Students may, therefore, be requested to participate in an assessment activity listed herein or other assessment identified by the College.
  - A. General Education Examination- this examination is designed to measure the effectiveness of the College's general education program.

- B. Major Field Examination- an examination designed to assess the level of student learning in a particular field of study and the effectiveness of instruction.
- C. Student Satisfaction Survey- this survey is designed to assess the level of student satisfaction with the College's academic and instructional programs.
- D. Instructional Evaluation Survey- a survey designed to assist the College in valuating instruction and individual faculty members to improve their teaching. Student confidentiality is ensured.
- III. The <u>Southwest Testing Center</u> provides access to various state and national tests, as well as exam proctoring service. Its <u>webpage</u> provides a list of available tests and services. The College's testing center is a member of the National College Testing Association (NCTA).
